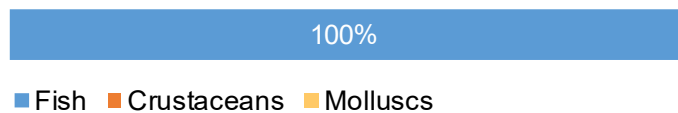

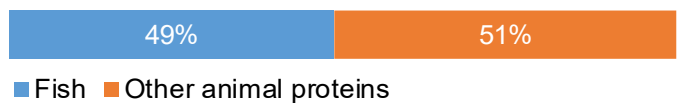

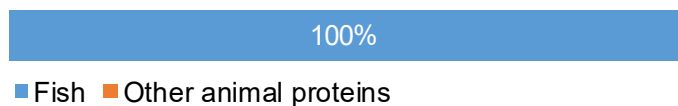
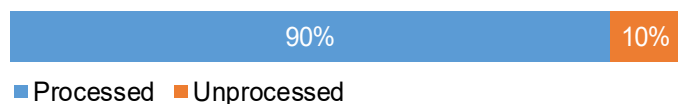
Production by volume
