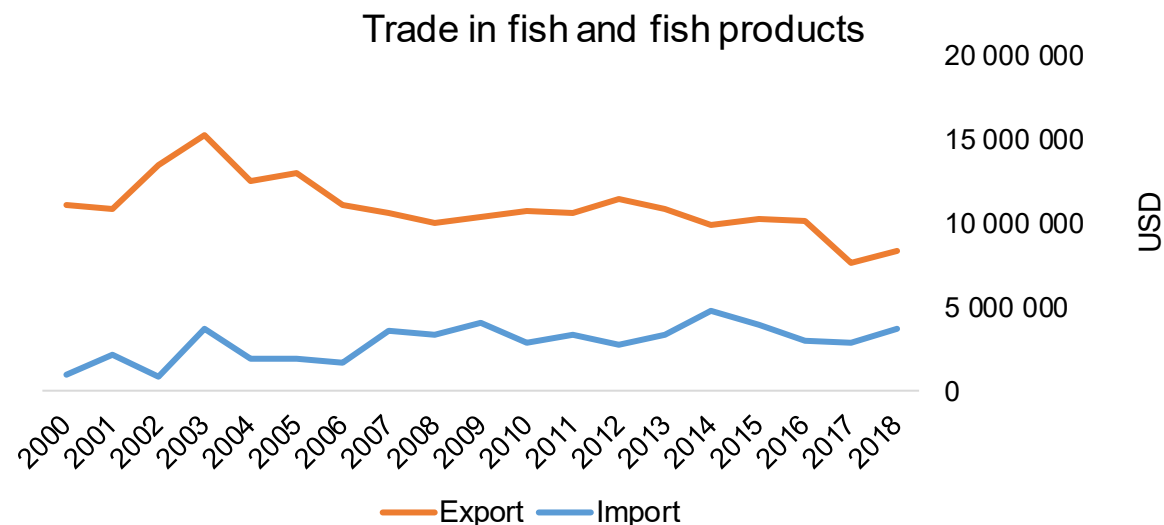

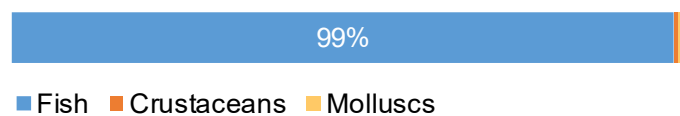

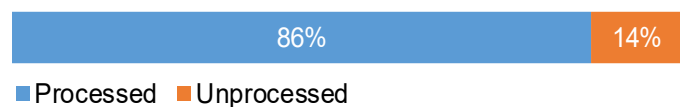

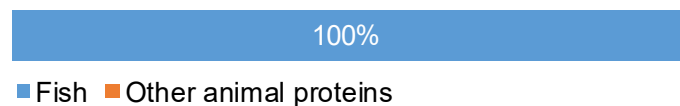
### Production by volume
