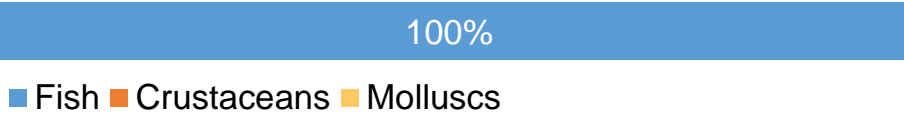

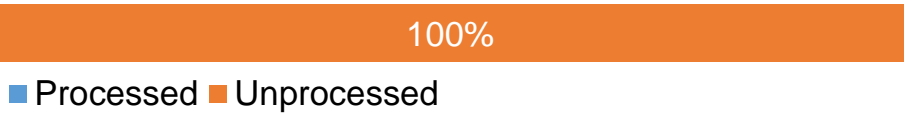
Production by volume
