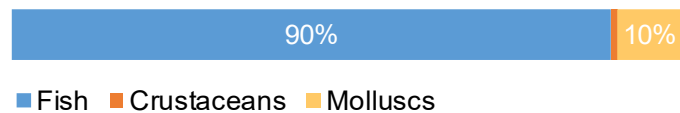

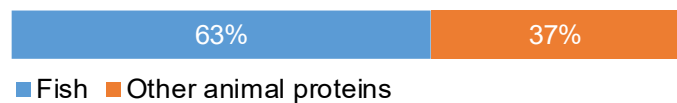
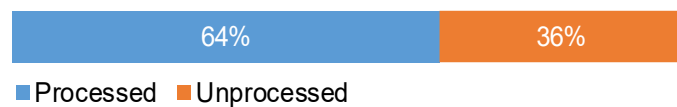

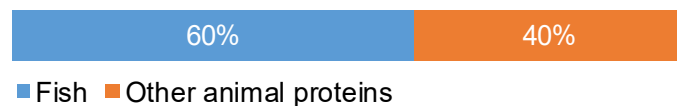
### Production by volume
