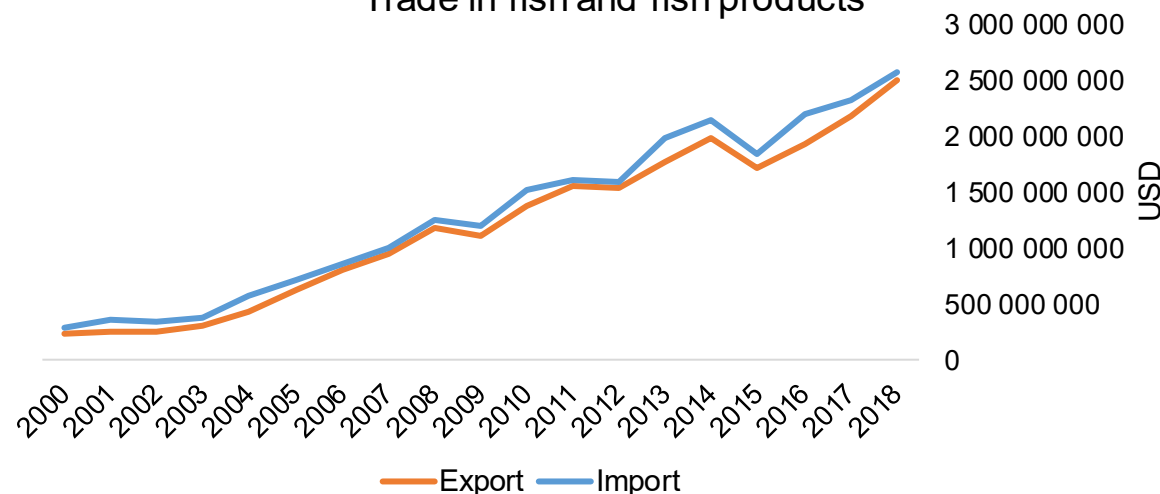

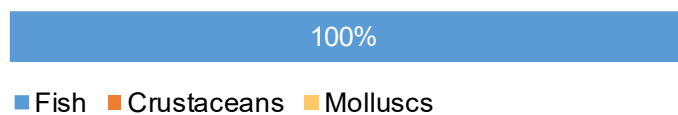

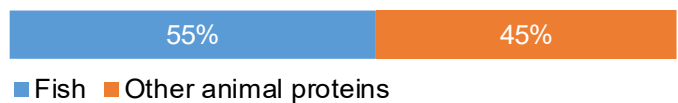

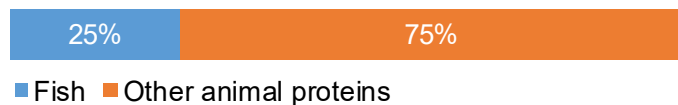
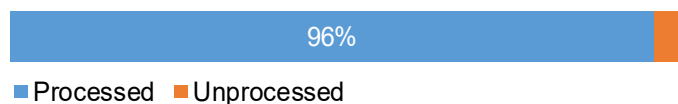
### Production by volume
