To fulfill this important aim, Portugal intervened at different levels, from the production to the commercialization, including education and regulation.

- the support the renewal and fixation of the farmers.
- the investment in training and research;



Furthermore, the Portuguese Government is creating the suitable conditions to establish short food circuits and local markets, a step that will facilitate the actions of local farmers.

On the other hand, for a better and higher equity of the value distribution along the food chain we promoted the dialogue among all the food chain partners in order to regulate and increase market transparency.

This year, following the joint recommendation of the Portuguese-speaking countries Organization (CPLP), Portugal also created the Food Safety Commission, with the objective of discuss the food safety related issues.



In an international perspective, and maintaining history and tradition, Portugal cooperate also with other nations.

In this perspective, a number of agricultural and agri-food Memorandums of Understanding (MoU) with different countries were establish, with special emphasis to the Portuguese-speaking ones.

This shows our commitment and willingness to cooperate with other nations in order to:

- Develop agriculture;
- Improve life quality;
- Fight Hunger;
- Create a new and fair society
