Inaugural FAO Treaty Ceremony

The Director-General of the Food and Agriculture Organization of the United Nations (FAO), acting in his capacity as depositary of seventeen (17) multilateral treaties approved by the Conference or the Council under Article XIV of the FAO Constitution, communicates the following:

An inaugural Treaty Ceremony will be held at FAO's headquarters during the 44th Session of the Conference to be convened in Rome from 28 June to 4 July 2025. At the Treaty Ceremony, Members may deposit instruments of ratification, accession, acceptance, approval or adherence with the Director-General, in person, in relation to Article XIV Treaties.

Members will recall that the Article XIV Treaties – all of which are in force and which are listed below – are multilateral agreements adopted by the Members concerning questions relating to food and agriculture. The Treaty Ceremony presents an opportunity for Members to reaffirm – on the 80th Anniversary of the Organization's establishment – their commitment to FAO's mandate and normative work, and their efforts to support achievement of the United Nations Sustainable Development Goals (SDGs) through the organizing principle of the *four betters*. Ministers and other Heads of Delegation participating in the Conference are encouraged to participate in the Treaty Ceremony.

The date and time of the Treaty Ceremony will be communicated to all Members in due course. In preparation for the Treaty Ceremony, Members that may consider depositing an instrument in respect of any of the Article XIV Treaties to which they are not already a Contracting Party are invited to contact the FAO Legal Office at treaties@fao.org as soon as possible for additional information and guidance.
