Session focus

This session aims at discussing how multi-level, multi-actor partnerships can contribute to inclusive and impactful land reforms and how successful experiences can be upscaled in other contexts. It will allow for critical reflection to better coordinate land interventions at national, regional, and global level to increase long-lasting impact.

With a combination of roundtable presentations on recent land reform cases and reflections in working groups, this session will specifically focus on the roles, the nature, the process stages, and the challenges of multi-stakeholders' partnerships for land reforms.

This session will showcase different examples of recent land reform which involved multi-stakeholder partnerships used as a basis to animate an interactive session with different stakeholders debating: What triggers inclusive land reforms and what is the knowledge gained in recent experiences? How have been the roles defined in these experiences? What are the nature and the process stages in these partnerships? What is still missing, what can be done better? How do we enable long-lasting impacts through multi-stakeholder partnerships? How do we better scale-up successful pilots/land interventions? What modes of joint action and collaboration can support multi-actor partnerships and land reform more effectively?
