**Raise ambition on the required policy action and investment needed to achieve SDG 1.4 by setting out the latest evidence on the case for tenure reform to achieve global priorities on climate mitigation, poverty reduction, stability, and human rights.**

**Drive action by (a) providing a platform for global champions to showcase their progress and influence others, and (b) by setting out credible pathways to scale action and finance.**

**Track country progress by highlighting data from SDG reporting, the Global Land Observatory (GLO) reports and other data sets.**
