The Host Government invites all the participants to attend a field visit to Walewice, a historic place with the 18th-century palace and the largest stud of Anglo-Arabian horses in Poland.

The Palace and the Stud are made famous by the Walewice Farm with a 200-year-old tradition, which conducts ecological cattle breeding, fish and plant production. The detailed program to be provided at the conference information desk and circulated by email to registered participants.
