### ELECTION OF SIX MEMBERS OF THE WFP EXECUTIVE BOARD

- In accordance with the Resolutions adopted by the United Nations General Assembly and the 30<sup>th</sup> Session of the FAO Conference in 1999 regarding the distribution of seats on the Executive Board starting from 1<sup>st</sup> January 2000, the Council is required to elect six members of the WFP Executive Board (1 from List A; 2 from List B; 1 from List C; and 2 from List D) for a term of office of three years for the period 1<sup>st</sup> January 2010 to 31 December 2012.
- For this period the following Member Nations have been nominated for the list indicated below:
